Reconstruction of Underground Electrical Facilities in Your Neighborhood

Dear Residents:

The City of Tallahassee Electric Department is preparing to upgrade the existing underground electric lines in your neighborhood in order to reduce the frequency of power outages and increase the reliability of electric service. Reconstruction of the underground electric system requires that all transformers be cleared of all shrubbery and trees.

In general, when designing or planting landscaping for the purpose of masking electrical transformers or other equipment, please remember that a minimum of three feet of clearance is required on three sides of these equipment and no tree or shrubbery is to be planted closer than ten feet from the front of transformers.

The reconstruction activities are scheduled to commence on Monday March 16th, 2020. Please remove any shrubbery or trees planted around electrical equipment that you would like to keep or replant elsewhere in your property prior to the start of the reconstruction activities no later than March 15th, 2020. The week of February 25th, 2020 serves as notification to remove any shrubbery or trees encumbering the reconstruction activities.

EQUIX Energy Services, LLC, is City's Contractor for placement of all underground infrastructure utilizing Direction Bore method; Direction Bore technique is designed to minimize disturbance to roadways and surface areas while placing new underground conduit system. As mentioned earlier in this letter, EQUIX Energy Services is scheduled to start the reconstruction activities no earlier than **March 16th**, **2020**.

Subject: Directional Bore Activity along Roadway

Dear Residents:

As the contractor for the City of Tallahassee, Equix Energy Services, LLC will be installing primary electric conduits throughout the Huntington Woods subdivision in order for new electric cables to be installed. We will be installing these conduits using directional boring and some open cut methods when necessary. Please refer to the attached letter from the City of Tallahassee for more details about the electric system installation.

Equix Energy will do everything reasonable to minimize the impact of the construction activities in your neighborhood. It will be necessary, however, to open some holes and/or ditches in order to accomplish the necessary construction. Directional boring is to be utilized to avoid open-cutting trenches to the greatest extent possible.

It is estimated that this project will require four to six weeks to complete depending on weather and other factors. The estimated start date will be March 16th. We will, of course, expedite the job as much as possible in order to avoid any interference to traffic, etc.
