Water pipes replacement

The City of Tallahassee has informed us that they plan to start the replacement of our community's water pipes next summer. Most repairs will be by the roadways to avoid trees and cabling. The water meters are not expected to be affected. They will be adding more fire hydrants. The roads will be repaired with pavement by the city. Our total roadway repaving plan will follow as soon as possible – very much depending on the road-fund investment value and contract financial negotiations. Will be updating developments throughout the next year.

From the Treasurer

- The \$475 for 2022 Assessments were due March 1, 2022. Eighty six of Ninety members have paid.
- The Current Road Fund is down 13% in value at \$297,365. The checking account balance \$6,672
