a. **Tennis Court Resurfacing** - Carlos / Sarah

The companies below have many years of experience. In addition to pressure washing, leveling, repairing cracks, and painting a pickle ball court - these differ in surface coatings and warranty as follows:

- 1) AAA Court Surfaces, Boca Raton, FL \$9,625  
Coats: One or two Acrylic resurfacer and color; Warranty 1 year
- 2) Zafircourt & Sons, Tampa, FL \$16,950  
Coats: Fiberglass mesh system, two coats of Acrylic resurfacer and color; Warranty 2 years

- 3) Elite Court, New York, NY \$77,164  
Pro-cushion base mat, two coats of Acrylic resurfacer and color; Warranty 5 years

- **PREVIOUS DISCUSSIONS:**

Coats: Two coats of sand-filled re-surfacer and two coats of sand-filled acrylic coatings
- 5) Premier Surfaces, Tallahassee, FL \$21,500 Warranty 1 year  
Same as 4) above plus two Riteway Crack repair kit/mesh, totaling up to 600' linear feet
