3. Other Highlights

From the Treasurer:

- Total Income in 2021 was \$50,500, incl. \$2,000 from Estoppels. All will go into the Road Fund after budgeted expenses are paid. We expect to need \$400K for the road repairs and repairs. The investment returns on this fund averaged 15% last year significantly exceeding an original goal of 5%.
- Sent the \$475 invoices for 2022 Assessments due March 1, 2022 from every homeowner.
- Two homeowners have 2021 delinquent assessments. Unfortunately, attorneys are processing liens.
- The Attorney is getting a better map for the official recording of the recently passed C&R updates.
